THE INCOME TAX ACT

(Cap. 81:01)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 14 OF THE INCOME TAX ACT, I HEREBY MAKE THE FOLLOWING ORDER:—

Citation. 1. This Order may be cited as the Income Tax (Exemption) (Deferment of Principal Payments) Order, 1983.

Interest exempt from income tax. 2. The interest due and payable by virtue of the Agreement dated as of the 30th day of March, 1983 among the Co-operative Republic of Guyana, the Original Obligors specified in the Agreement, the Banks specified in the Agreement and the Royal Bank of Canada, a Canadian Chartered Bank having its head office and principal place of business in the City of Montreal, Province of Quebec, Canada shall from that date be exempt from income tax.
